A recent study of Georgia veteran's courts by Applied Research Services was featured in the Daily Report. The article "Veterans Courts Mix Success With Big Challenges "discusses the study's findings that, of 890 defendants referred into Georgia's VTC programs from October 2014 to September 2017, 529 enrolled in the accountability court program, and 51 percent graduated successfully. # **CACJ SECOND QUARTER NEWS**

#### **FY19 SUPPLEMENTAL GRANT REVIEW**

The Council of Accountability Court Judges Funding Committee met November 9, 2018 to review FY19 Supplemental Grant applications. Two additional first time grant opportunities were also reviewed, the Law Enforcement Officer Support (LEO) grant and Substance Abuse and Mental Health Services Association (SAMHSA) grant for Family Treatment Courts. Three new implementation programs were also awarded during the FY19 Supplemental Grant review.

- Dawson County Family Treatment Court
- Rockdale County Juvenile Mental Health Court
- Mountain Judicial Circuit Mental Health Court
- Gwinnett State Veterans Treatment Court

The new programs will increase the number of accountability courts in Georgia to 160 as of January 1, 2019!

Also, the FY20 Notice of Intent (NOI) to apply for funding is available. Each currently CACJ funded program is required to complete the form. In addition, if a circuit has planned to implement a new program during FY20, a NOI is required for the planned program. Notice is due by 5:00 pm on December 14, 2018. # Second class graduates from Drug Court

The second class of graduates of the South Georgia Judicial Circuit Accountability Felony Drug Court was recognized during a ceremony last Thursday at the Grady County Courthouse.

Graduates Dustin Fain, Robert Kelly and Albert Bufford were honored for completing the 18-24 month intensive program designed to help addicts kick the habit and stay out of jail.

The drug court has been spearheaded by Superior Court Judge J. Kevin Chason and is grant funded. Coordinator Mary Brown manages the day-to-day operations of the court in consultation classes. with Judge Chason.

In order to graduate, the students must participate in the program at least 18 months, pay \$30 per month, test negative for any drugs during random testing, meet curfew requirements, and attend special training

The first class of graduates was recognized in July. The first five to graduate were Sam Frisbie, Bryant Horton, Chris Maples, Brandon Osborn, and Morgan Ulm.
